The remaining balance has not been paid and the work is not signed off on.

Potholes in the association road have been filled.

Weeds and trees that were laying along the front fencing (white fence) have been removed. The weeds along the runway are being weed whacked two (2) feet from the sides of the runway. To really get the work accomplished a mowing tractor is needed. A motion is made and seconded (Pete/Randy) to rent for one week a mowing tractor with five (5) foot deck, not to exceed \$2,200. This amount to include labor. This amount does not include fuel. All in favor. Motion carries.

The runway signs are on hold until steel is purchased, and Chris Elsmore has been trained in welding.

The dirt relocation will now be put under "Common Area Development" and tabled until next year's budget is reviewed.

The installation of the new mailboxes is on hold until the Postmaster can determine the thickness of cement they require and get specs to Pete. *If you have a new lot with RSAPOA you may have to contact the Sahuarita Postmaster to have a mailing address assigned.*

An "Action Taken Without a Meeting" has passed the revised bylaws. This will streamline the election process and make it more transparent for the membership. The Bylaws have been revised and restated in its entirety in order to incorporate all amendments and revisions into one single document. A subsequent version will be voted on by the board after review by the association attorney.

New Business:

The priority roads for 2020 are: West Lost Emerald, North Ruby Star Airpark and more runway millings along the runway. Should monetary funds and budget stay equitable more roads and projects will be considered for 2020.
