- <u>Bates Paving Bids</u>: West Lost Emerald \$26,000, North Ruby Star Airpark \$38,000 The board discusses a small special assessment to pay for one of the projects this year. For instance, if West Lost Emerald is done there is \$9,000 in reserves and \$10,000 in the budget that can be used. The remaining balance to complete the job would be \$7,000. A special assessment could be requested from the membership of approximately \$115-\$120 per lot. This item will be placed on the next agenda for further discussion.
 - <u>Weed removal</u>: It is agreed a mowing tractor will be rented. Someone to work the mower for a week still needs to be found.
 - Bylaw update: Attorney is finishing her review and will have a finalized draft ready for review soon.
